ORDINANCE NO. 03-5-14
AN ORDINANCE
MAKING APPROPRIATIONS FOR CORPORATE PURPOSES FOR
THE FISCAL YEAR BEGINNING MAY 1, 2003
AND ENDING APRIL 30, 2004
IN THE VILLAGE OF RINGWOOD

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF
RINGWOOD, ILLINOIS, as follows:

SECTION 1. That the following sums, or so much thereof as hereby may be authorized
by law, be and the same are hereby appropriated to pay all necessary expenses and liabilities of
the Village of Ringwood, McHenry Township, McHenry County, Illinois, for the fiscal year
beginning May 1, 2003, and ending April 30, 2004, an aggregate sum of seven hundred forty one
thousand, seven hundred fifty-eight dollars (\$741,758.00); such appropriations are hereby made
