ORDINANCE NO. 2005-1-2  
AN ORDINANCE AMENDING SECTION 608.1 OF THE SUBDIVISION  
CONTROL ORDINANCE RELATING TO BASE COURSE, BITUMINOUS  
SURFACE COURSE AND SHOULDER PROVISIONS

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE  
VILLAGE OF RINGWOOD, ILLINOIS, as follows:

SECTION 1. Section 608.1 of the Subdivision Control Ordinance relating to base  
course, bituminous surface course and shoulder provisions is hereby amended to read as  
follows:

Base Course	26' Wide - 8" Aggregate Base (Compacted Thickness) and 24' Wide - 7" Bituminous Base Course (Superpave)	33' wide - 8" Aggregate Base (Compacted Thickness), and 31' Wide - 7" Bituminous Base Course (Superpave)	39' Wide - 4" Aggregate Base (Compacted Thickness), and 36' Wide - 9" Bituminous Base Course (Superpave)

	RESIDENTIAL STREETS	MAJOR RESIDENTIAL STREETS	BUSINESS AND INDUSTRIAL ACCESS STREETS
Bituminous Surface Course	24' Wide - 2" N50 Surface (Superpave)	31' Wide - 2" N50 Surface (Superpave)	36' wide - N 70 (Superpave) consisting of 2 1/2" Binder and 1 1/2" Surface
Shoulder	Integral with Surface - 2' Wide	Integral with Surface - 2' Wide	No Shoulder - Curb and Gutter Req'd Type B- 6.12

**SECTION 2.** Any person, firm or corporation violating any provision of this ordinance shall be fined not less than Fifty Dollars (\$50.00) nor more than Seven Hundred Fifty Dollars (\$750.00) for each offense committed on each day during, or on which, a violation occurs or continues.

**SECTION 3.** All ordinances, or parts thereof, in conflict with the terms and provisions hereof, be and the same are hereby repealed to the extent of such conflict.

**SECTION 4.** This ordinance shall be published in pamphlet form by and under the authority of the Corporate Authorities of the Village.

**SECTION 5.** This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form, as provided by law.
