**ORDINANCE NO. 2006-10-3**

**AN ORDINANCE ESTABLISHING THE  
ZONING DISTRICT CLASSIFICATION  
OF NEWLY ANNEXED TERRITORY  
TO THE VILLAGE OF RINGWOOD,  
MCHENRY COUNTY, ILLINOIS**

WHEREAS, the following described real estate commonly known as the Reichert Parcel and is located at the North side of Ringwood Road East of Route 31 in Ringwood, McHenry Township, McHenry County, Illinois., in Ringwood, Illinois, has been newly annexed to the Village of Ringwood, McHenry County, Illinois:

**Legal Description- Zoning Petition**

The South Half of the Southwest Quarter and the Northwest Quarter of the Southwest Quarter of Section 3, Township 45 North, Range 8 East of the Third Principal Meridian, in McHenry County, Illinois, ALSO

That part of the Northwest Quarter of Section 10 lying Northwesterly of the Northwesterly line of Ringwood Road and Northeasterly of the Northeasterly Line of Illinois Route 31; EXCEPTING therefrom that tract identified as the Assessor's Plat of the West Half of Section 10; and also EXCEPTING therefrom that part of the Northwest Quarter of Section 10 described as follows: Commencing at the point of intersection of the east line of the Northwest Quarter aforesaid and the center line of Ringwood Road; thence Southwesterly along said center line, 691.65 feet for a place of beginning; thence continuing Southwesterly along said center line, 420.55 feet; thence Northwesterly at an angle of 117 degrees, 34 minutes, 20 seconds measured counter-clockwise from the last described course, 504.08 feet; thence Northeasterly parallel with the center line of Ringwood Road, 552.65 feet; thence Southeasterly at an angle of 77 degrees, 14 minutes, measured counter-clockwise from the last described course, 458.17 feet to the place of beginning, all in Township 45 North, Range 8 East of the Third Principal Meridian, in McHenry County, Illinois.

WHEREAS, a hearing was conducted before the Ringwood Zoning Board of Appeals on the request to zone the following described lot to R-1 Single Family Zoning District under the Village of Ringwood ordinance as follows:

NOW THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF RINGWOOD, MCHENRY COUNTY, ILLINOIS, as follows:

SECTION 1: The above described real estate and territory which is commonly known as Reichert Parcel and located on the North side of Ringwood Road, East of Route 31 in Ringwood, McHenry Township, McHenry County, Illinois is hereby classified under the terms and provisions of the Village of Ringwood Zoning Ordinance as follows:

R-1 Single Family Zoning District and is legally described as :

**Legal Description- Zoning Petition**
