ORDINANCE NO. 2006-2- 1
AN ORDINANCE PROVIDING FOR THE APPROVAL
OF AN ANNEXATION AGREEMENT

WHEREAS, Laurie Stade is the record owner of the real estate legally described on
the attached Exhibit "A"; and,

WHEREAS, said real estate is contiguous to the existing corporate limits of the
Village of Ringwood, McHenry County, Illinois; and

WHEREAS, notice of public hearing was published in the Northwest Herald, a
newspaper of general circulation in the Village, within the time provided by law, notifying
the public of a hearing on said proposed annexation Agreement to be held before the
Corporate Authorities of the Village of Ringwood, McHenry County, Illinois.

WHEREAS, the Corporate Authorities of the Village of Ringwood have held the
hearing as required by law and have found the entry into said Agreement is in the public
interest and will not be detrimental to the public health, welfare, or safety of the inhabitants
of the Village of Ringwood, McHenry County, Illinois;

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF RINGWOOD, McHENRY COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1. The Annexation agreement bearing the date of February 20, 2006, by and between the Village of Ringwood, a Municipal Corporation in the State of Illinois, and Laurie Stade be and the same is hereby approved. A complete and accurate copy of said Annexation Agreement is attached to this ordinance and incorporated herein by reference as Exhibit "B".

SECTION 2. The President and Village Clerk of the Village of Ringwood are authorized to affix their signatures as President and Village Clerk of said Village to said Agreement for the uses and purposes therein set forth.

SECTION 3. This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form, as provided by law.
