AN ORDINANCE ADOPTING VILLAGE OF RINGWOOD 2030 LAND USE PLAN

WHEREAS, the Corporate Authorities of the Village have caused a Comprehensive Plan to be prepared, which is entitled "Village of Ringwood 2030 Comprehensive Land Use Plan", and have referred it to the Plan Commission for its consideration and recommendation thereon;

AND WHEREAS, the Plan Commission has conducted a public hearing thereon, has considered said Plan and has recommended that the Village President and the Board of Trustees adopt the said Comprehensive Plan, as and for the Official Comprehensive Plan of the Village of Ringwood, Illinois;

AND WHEREAS, the Board of Trustees has considered said Comprehensive Plan, together with the recommendation of the Plan Commission, and finds the adoption of the Comprehensive Plan to be in the public interest;

NOW THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF RINGWOOD, McHENRY COUNTY, ILLINOIS, as follows:

SECTION 1. That the aforesaid recommendation of the Plan Commission be and it is hereby accepted and approved.

SECTION 2. That the above-described Comprehensive Plan be and the same is hereby incorporated herein by reference and is hereby adopted as part of this Ordinance as the Official Comprehensive Plan of the Village of Ringwood, Illinois.

SECTION 3. The Official Comprehensive Plan of the Village of Ringwood, Illinois shall be identified by the following statement marked or stamped thereon:

"Adopted by reference as part of the Comprehensive Plan Ordinance passed on MARCH 27, 2006 by the Board of Trustees of the Village of Ringwood, Illinois, approved by Richard E. Mack, Village President, and attested by Veronica Gaddis, Village Clerk."

SECTION 4. At least three copies of this Ordinance shall be kept by the Office of the Village Clerk for inspection by interested persons. The Village Clerk shall also make available copies of the Ordinance and Comprehensive Plan for purchase at a price of \$ 10.00. the foregoing copies of the Ordinance shall be in addition to the original copy which the Statutes require the Clerk to keep as part of the official record of enacted ordinances.

SECTION 5. Any person, firm or corporation violating any provision of this ordinance shall be fined not less than One Hundred Dollars (\$100.00) nor more than Seven Hundred Fifty Dollars (\$750.00) for each offense committed on each day during, or on which, a violation occurs or continues.

SECTION 6. All ordinances, or parts thereof, in conflict with the terms and provisions hereof, be and the same are hereby repealed to the extent of such conflict.

SECTION 7. This ordinance shall be published in pamphlet form by and under the authority of the Corporate Authorities of the Village of Ringwood, Illinois..

SECTION 8. This ordinance shall be in full force and effect from and after its passage, approval publication in pamphlet form and filing of Notice of Adoption, in the Office of the McHenry County Recorder of Deeds as provided by law.
