AN ORDINANCE ADOPTING AN OFFICIAL MAP PURSUANT TO 65 ILCS 5/11-12-6

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE
VILLAGE OF RINGWOOD, ILLINOIS, as follows:

SECTION 1. It is the purpose of this Ordinance (a) to adopt an Official Map pursuant to 65 ILCS 5/11-12-6, a copy of which is attached hereto as Exhibit 1 and (b) to provide for the filing of copies of such maps and standards in the office of the Village Clerk for the information of the public.

SECTION 2. The aforesaid Exhibit 1 is incorporated herein by reference and is hereby adopted as the Official Map governing the development of the Village and of contiguous territory outside of the Village within one and one-half miles from its Corporate limits or within such distance as modified by jurisdictional boundary agreements between the Village and other municipalities.

SECTION 3 The aforesaid Official Map shall be identified by the following statement marked, stamped, printed or written thereon:

"Adopted by reference as a part of the Official Map Ordinance passed on MARCH 27, 2006, by the Board of Trustees of the Village of Ringwood, Illinois, approved by Richard E. Mack, Village President, and attested by Veronica Gaddis, Village Clerk."

SECTION 4. The aforesaid Official Map may be adopted by reference in other ordinances which regulate the development of the municipality without further filing or publication except where the Statutes require otherwise.

SECTION 5. The standards and specifications contained in the "Subdivision Ordinance" of the Village of Ringwood, Illinois, relating to the design, layout and installation of Streets, Alleys, Curbs and Gutters, Sanitary Sewerage, Storm Water Drainage, Water Supply and Distribution, Street Lighting, Sidewalks, Street Signs, Public Utility Locations, Guard Rails and Landscaping, and Block and Lot Layout be and the same are hereby incorporated herein by reference and adopted as part of this Ordinance.

SECTION 6. The provisions of this Ordinance shall be enforced by the Building Inspector.

SECTION 7. At least three copies of this Ordinance shall be kept by the Office of the Village Clerk for inspection by interested persons. The Village Clerk shall also make available copies of the Official Map for a purchase price of \$ 5.00 either through duplication in advance of contemplated demand or upon order as required. the foregoing copies of the Ordinance shall be in addition to the original copy which the Statutes require the Clerk to keep as part of the official record of enacted ordinances.

SECTION 8. Any person, firm or corporation violating any provision of this ordinance shall be fined not less than One Hundred Dollars (\$100.00) nor more than Seven Hundred Fifty Dollars (\$750.00) for each offense committed on each day during, or on which, a violation occurs or continues.

SECTION 9. All ordinances, or parts thereof, in conflict with the terms and provisions hereof, be and the same are hereby repealed to the extent of such conflict.

SECTION 10. This ordinance shall be published in pamphlet form by and under the authority of the Corporate Authorities of the Village of Ringwood, Illinois..

SECTION 5. This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form, as provided by law.
