ORDINANCE NO.2006-5- 2  
AN ORDINANCE AMENDING THE DRAM SHOP ORDINANCE  
OF THE VILLAGE OF RINGWOOD

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE  
VILLAGE OF RINGWOOD, ILLINOIS, as follows:

SECTION 1. Section 21 of the Dram Shop Ordinance of the Village of Ringwood  
is hereby amended to read as follows:

"Section 21. Closing Hours. It is unlawful to keep open or  
permit to be opened any place where alcoholic liquor is sold for  
consumption on or off the premises between the hours of 1:00  
o'clock a.m. and 11:00 o'clock a.m. on any Sunday, Monday,  
Tuesday, Wednesday and Thursday and between the hours of  
2:00 o'clock a.m. and 11:00 o'clock a.m. on any Friday and  
Saturday, provided, however, that a licensee hereunder may  
remain open until 2:00 o'clock a.m. on New Year's Day, the  
day after St. Patrick's Day (March 18th) and on Thanksgiving  
Day.

SECTION 2. Section 9 of the Village Dram Shop Ordinance is hereby amended to  
add thereto a Class B License as follows:

"Class B: Which shall permit the holder of a Class A license  
to remain open from 8:00 a.m. to 11:00 a.m. on Saturday and  
Sunday mornings, provided, however, that no alcoholic liquor

may be served by such licensee to any patron who has not also ordered a meal with such alcoholic liquor. The annual fee for the Class B license shall be Eight Hundred Dollars.

SECTION 3. Section 10 of the Dram Shop Ordinance of the Village of Ringwood is hereby amended to read as follows:

"Section 10. Licenses - Number. There shall be issued in the Village no more than 2 Class A licenses nor more than 2 Class B licenses to be in effect at any one time.

SECTION 4. Any person, firm or corporation violating any provision of this ordinance shall be fined not less than Fifty Dollars (\$50.00) nor more than Seven Hundred Fifty Dollars (\$750.00) for each offense committed on each day during, or on which, a violation occurs or continues.

SECTION 5. All ordinances, or parts thereof, in conflict with the terms and provisions hereof, be and the same are hereby repealed to the extent of such conflict.

SECTION 6. This ordinance shall be published in pamphlet form by and under the authority of the Corporate Authorities of the Village.

SECTION 7. This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form, as provided by law.
