AN ORDINANCE AMENDING SECTION 12-321 OF THE MOTOR VEHICLE
AND TRAFFIC ORDINANCE RELATING TO SPEED RESTRICTIONS ON
BARNARD MILL ROAD WEST OF SCHOOL STREET

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE
VILLAGE OF RINGWOOD, ILLINOIS, as follows:

SECTION 1. Speed limits for Barnard Mill Road west from School Street as
provided in Sections 12-321E and 12-321F are hereby repealed.

SECTION 2. Section 12-321D, providing for thirty (30) mile per hour speed limit
roads is hereby amended by adding thereto the following additional road:

Barnard Mill Road from a distance of 386 feet west of School
Street for a distance of 718 feet.

SECTION 3. Section 12-321E, providing for forty (40) mile per hour speed limit
roads is hereby amended by adding thereto the following additional road:

Barnard Mill Road from a distance of 1,104 feet west of
School Street west to the Village limits.

SECTION 4. All ordinances, or parts thereof, in conflict with the terms and
provisions hereof, be and the same hereby are repealed to the extent of such conflict.

SECTION 5. This ordinance shall be published in pamphlet form by and under the
authority of the Corporate Authorities of the Village.

SECTION 6. This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form, as provided by law.
