AN ORDINANCE AMENDING THE YEAR 2010 LAND USE PLAN  
MAP CATEGORY OF NEWLY ANNEXED TERRITORY  
TO THE VILLAGE OF RINGWOOD, MCHENRY COUNTY, ILLINOIS

WHEREAS, the real estate legally described on the attached Exhibit "A" has been newly annexed to the Village of Ringwood, McHenry County, Illinois, to-wit:

WHEREAS, the above described real estate is subject to an annexation agreement which provides, among other things, that upon annexation thereof to the Village of Ringwood, Illinois, the aforesaid territory shall be designated "Industrial (Non - Manufacturing)" land use category on the Village 2010 Land use Plan Map in accordance with the terms and provisions contained in said annexation agreement; and,

WHEREAS, prior to the annexation of the above described territory and the entry into the aforesaid annexation agreement between the parties therein, all public hearings required by law to be held were conducted and held pursuant to proper legal notice theretofore given.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF RINGWOOD, ILLINOIS, as follows:

SECTION 1. That the above described real estate and territory is hereby designated "Industrial (Non - Manufacturing)" land use category on the Village 2010 Land use Plan Map in accordance with the terms and provisions of the Village Comprehensive Map.

SECTION 2. The 2010 Land Use Plan Map of the Village of Ringwood, Illinois shall reflect the "Industrial (Non - Manufacturing)" land use category designation of the aforesaid premises in accordance with the Village Comprehensive Plan.
