**AN ORDINANCE PROVIDING FOR THE ANNEXATION
OF CERTAIN DESCRIBED REAL ESTATE TO THE
VILLAGE OF RINGWOOD, ILLINOIS**

WHEREAS, First Midwest Bank as Trustee under Trust Agreement dated January 8,
2003, and known as Trust No. 13375, is the record owner of the real estate which is legally
described on Exhibit "G" attached hereto and by this reference made apart hereof.

PIN# 09-05-351-002; 09-05-351-003; 09-05-351-005; 09-05-351-006; 09-05-351-007; 09-08-
101-001; 09-05-376-002; 09-08-102-001; and 09-05-352-001.

WHEREAS, no electors reside on the real estate described above; and

WHEREAS, said real estate is contiguous to the existing corporate limits of the Village
of Ringwood, Illinois, and is not located within any other municipality; and the aforesaid record
owner desires annexation of said real estate to the Village of Ringwood, Illinois, and has
petitioned the corporate authorities of the Village of Ringwood, Illinois, in writing and under
oath, for annexation of said real estate; and

WHEREAS, the Village of Ringwood does not provide public library nor fire protection
service and therefore *statutory notice* is not required to be given to those legal entities designated
in the statutes;

WHEREAS, the real estate abuts roads under the jurisdiction of McHenry Township and notice has been served on the Township Commissioner of Highways and Board of Town Trustees.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF RINGWOOD, McHENRY COUNTY, ILLINOIS, as follows:

Section 1: The above described real estate be and the same is hereby annexed to the Village of Ringwood, Illinois, including any and all portions of adjacent streets, roads, or highways, as required by law.

Section 2: The Village Clerk is hereby directed to cause an accurate map of the real estate described and annexed and a certified copy of this Ordinance to be recorded in the Office of the Recorder of Deeds, McHenry County, Illinois. Following such recordation, a copy thereof shall be filed in the Office of the Clerk of McHenry County, Illinois.

Section 3. This Ordinance shall be in full force and effect immediately after its passage and approval as required by law.

PARCEL 8: THE WEST 1/2 OF THE NORTHWEST 1/4 OF SECTION 8 (EXCEPT THE SOUTH 20 ACRES THEREOF, AND ALSO EXCEPTING THAT PORTION OF PLEASANT VALLEY SUBDIVISION, UNIT NO. 1, AS RECORDED IN THE MCHENRY COUNTY PLAT BOOK 11, PAGE 52, LYING WITHIN THE BORDERS OF THE FIRST ABOVE-DESCRIBED WEST 1/2 OF THE NORTHWEST 1/4 OF SECTION 8 AFORESAID) IN TOWNSHIP 45 NORTH, RANGE 8 EAST OF THE THIRD PRINCIPAL MERIDIAN, IN MCHENRY COUNTY, ILLINOIS.
