**ORDINANCE NO. 2006-10-02**

**AN ORDINANCE PROVIDING FOR THE ANNEXATION**  
**OF CERTAIN DESCRIBED REAL ESTATE TO THE**  
**VILLAGE OF RINGWOOD, ILLINOIS**

WHEREAS, HOME STATE BANK, as Trustee under Trust Agreement dated  
April 24, 1997 and known as Trust No. 4527, owner, and MCHENRY LAND  
VENTURES LLC, Contract Purchaser of the following described real estate:

**Legal Description- Annexation Petition**

The South Half of the Southwest Quarter and the Northwest Quarter of the Southwest  
Quarter of Section 3, Township 45 North, Range 8 East of the Third Principal Meridian,  
in McHenry County, Illinois, ALSO

That part of the Northwest Quarter of Section 10 lying Northwesterly of the  
Southeasterly Line of Ringwood Road and Northeasterly of the Northeasterly Line of  
Illinois Route 31; EXCEPTING therefrom that tract identified as the Assessor's Plat of  
the West Half of Section 10; and also EXCEPTING therefrom that part of the Northwest  
Quarter of Section 10 described as follows: Commencing at the point of intersection of  
the east line of the Northwest Quarter aforesaid and the center line of Ringwood Road;  
thence Southwesterly along said center line, 691.65 feet for a place of beginning; thence  
continuing Southwesterly along said center line, 420.55 feet; thence Northwesterly at an  
angle of 117 degrees, 34 minutes, 20 seconds measured counter-clockwise from the last  
described course, 504.08 feet; thence Northeasterly parallel with the center line of  
Ringwood Road, 552.65 feet; thence Southeasterly at an angle of 77 degrees, 14 minutes,  
measured counter-clockwise from the last described course, 458.17 feet to the place of  
beginning, all in Township 45 North, Range 8 East of the Third Principal Meridian, in  
McHenry County, Illinois.

WHEREAS, no electors reside on the real estate described above; and

WHEREAS, said real estate is contiguous to the existing corporate limits of the Village of Ringwood, Illinois, and is not located within any other municipality; and the aforesaid record owner desires annexation of said real estate to the Village of Ringwood, Illinois, and has petitioned the corporate authorities of the Village of Ringwood, Illinois, in writing and under oath, for annexation of said real estate; and

WHEREAS, the Village of Ringwood does not provide public library nor fire protection service and therefore statutory notice is not required to be given to those legal entities designated in the statutes;

WHEREAS, notice was sent to the Township Officials and the same notice was recorded at the McHenry County Office of the Recorder of Deeds as required by statute;

NOW THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF RINGWOOD, MCHENRY COUNTY, ILLINOIS, as follows:

SECTION 1: The following described real estate be and the same is hereby annexed to and made a part of the corporate limits of the Village of Ringwood, Illinois, including any and all portions of adjacent streets, roads, or highways, as required by law:

The South Half of the Southwest Quarter and the Northwest Quarter of the Southwest Quarter of Section 3, Township 45 North, Range 8 East of the Third Principal Meridian, in McHenry County, Illinois, ALSO

That part of the Northwest Quarter of Section 10 lying Northwesterly of the Southeasterly Line of Ringwood Road and Northeasterly of the Northeasterly Line of Illinois Route 31; EXCEPTING therefrom that tract identified as the Assessor's Plat of the West Half of Section 10; and also EXCEPTING therefrom that part of the Northwest Quarter of Section 10 described as follows: Commencing at the point of intersection of the east line of the Northwest Quarter aforesaid and the center line of Ringwood Road; thence Southwesterly along said center line, 691.65 feet for a place of beginning; thence continuing Southwesterly along said center line, 420.55 feet; thence Northwesterly at an angle of 117 degrees, 34 minutes, 20 seconds measured counter-clockwise from the last described course, 504.08 feet; thence Northeasterly parallel with the center line of Ringwood Road, 552.65 feet; thence Southeasterly at an angle of 77 degrees, 14 minutes, measured counter-clockwise from the last described course, 458.17 feet to the place of beginning, all in Township 45 North, Range 8 East of the Third Principal Meridian, in McHenry County, Illinois.

Following such recordation, a copy thereof shall be filed in the Office of the Clerk of McHenry County, Illinois.

SECTION 3: This Ordinance shall be in full force and effect immediately after its passage and approval as required by law.
