ORDINANCE NO. 0-6-11-
AN ORDINANCE PROHIBITING CLASS F AND HIGHER LICENSE
PLATE CLASS VEHICLES ON CERTAIN VILLAGE STREETS

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE
VILLAGE OF RINGWOOD, ILLINOIS, as follows:

SECTION 1. The Motor Vehicle and Traffic Ordinance (Chapter 12) of the Village
of Ringwood is hereby amended by adding thereto the following provision as and for
Section 12-1008.2 thereof:

"Section 12-1008.2. No vehicle licensed with a Class F or
higher license plate class, unladen or laden, shall be operated
upon the following designated streets or highways of the
Village of Ringwood except to a point of loading or unloading
thereon:

School Road
Inmans Way
North Ridgeway Road
South Ridgeway Road
Beck Lane
Monroe Street
Glacial Trail
Kame Trail
Pioneer Oaks Drive
Justen Lane
Barnard Mill Road (between Van Buren and Route 31)

SECTION 2. Whenever any vehicle is operated in violation of provisions of Section 12-1008.2 aforesaid the owner or driver, or both, of such vehicle shall be deemed guilty of such violation and either or both the owner and the driver of such vehicle may be prosecuted for such violation. Any person, firm, association, co-partnership or corporation convicted of any violation of Section 12-1008.2 shall be fined as follows: if such vehicle is unladen the fine shall be not less than \$750.00; if such vehicle is laden but its laden weight is not in excess of the maximum gross weight allowed by Section 12-1008, the fine shall be not less than \$750.00 and, in addition thereto, an amount equal to two cents per pound for each pound of laden weight up to the maximum gross weight allowed by Section 12-1008.

SECTION 3. All ordinances, or parts thereof, in conflict with the terms and provisions hereof, be and the same are hereby repealed to the extent of such conflict.

SECTION 4. This ordinance shall be published in pamphlet form by and under the authority of the Corporate Authorities of the Village.

SECTION 5. This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form, as provided by law.
