Ordinance No. 18-12-1
An Ordinance Requiring Underground Powerlines

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE
VILLAGE OF RINGWOOD, ILLINOIS, as follows:

SECTION 1. Any and all powerlines installed in the Village shall be installed underground, from the main lines to a residence, commercial structure, industrial structure, and any accessory structure.

SECTION 2. All ordinances, or parts thereof, in conflict with the terms and provisions hereof, be and the same are hereby repealed to the extent of such conflict.

SECTION 3. This ordinance shall be published in pamphlet form by and under the authority of the Corporate Authorities of the Village.

SECTION 4. This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form, as provided by law.

Ordinance No. 18-12-2
An Ordinance Requiring Paved Driveways

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE
VILLAGE OF RINGWOOD, ILLINOIS, as follows:

SECTION 1. Any and all construction in the Village shall include paved driveways. Any and all construction shall include construction that includes additions to a building or land or repairs on more than fifty (50) percent of a building; for such construction all existing driveways shall be paved. This includes all residential, commercial and industrial properties within the Village.

SECTION 2. All ordinances, or parts thereof, in conflict with the terms and provisions hereof, be and the same are hereby repealed to the extent of such conflict.

SECTION 3. This ordinance shall be published in pamphlet form by and under the authority of the Corporate Authorities of the Village.

SECTION 4. This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form, as provided by law.
