ORDINANCE NO. 2025 - 5 - 05

AN ORDINANCE AMENDING SECTION 3-9, 5-05 OF THE VILLAGE OF RINGWOOD BUILDING CODE AND BUILDING REGULATIONS ORDINANCE

ADOPTED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF RINGWOOD THIS 19TH DAY OF MAY 2025

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF RINGWOOD, ILLINOIS, pursuant to its statutory and plenary powers as granted under Illinois law, as follows:

SECTION 1. Article One, Section 3-9.A of the Village of Ringwood Building Code and Building Regulations Ordinance is hereby amended and shall be as follows:

3-9 Garbage and Dumpster Enclosures. Amended as follows.

A) All commercial dumpsters, in any Zoning District, shall be kept in a stockade wood fence or masonry/concrete enclosure located in the rear yard setback of the premises from which it is to be collected. The fenced enclosure shall be not less than 6 feet in height from the ground level and all fence posts and supporting fence members shall be erected so that after the fence is constructed, the fence post and supporting members will face to the interior of the fence enclosure. All other containers used for solid waste, landscape waste, or recyclables shall be kept at the rear or side of any premises or in a fully enclosed area, except when they are properly placed for collection for the scheduled days for collection. If the placement restrictions herein are not practicable for a property, the property owner must request a reasonable alternative placement, which must be reviewed and approved by the Village Board of Trustees.

SECTION 2. That if any section, subsection, sentence, clause or phrase of this legislation is, for any reason, held to be unconstitutional, such decision shall not affect the validity of the remaining portions of this ordinance. The Village of Ringwood hereby declares that it would have passed this law, and each section, subsection, clause or phrase thereof, should any one or more sections, subsections, sentences, clauses and phrases be declared unconstitutional.

An Ordinance Amending the Village of Ringwood Zoning Ordinance

SECTION 3. That nothing in this legislation or in the 2015 International Residential Building Code or in the 2015 International Building Code hereby adopted shall be construed to affect any suit or proceeding impending in any court, or any rights acquired, or liability incurred.

SECTION 4. That the Village Clerk is hereby ordered and directed to cause this legislation to be published in pamphlet form by authority of the President and Board of Trustees of the Village of Ringwood, McHenry County, Illinois.

SECTION 5. That this law and the rules, regulations, provisions, requirements, orders and matters established and adopted hereby shall take effect and be in full force and effect immediately, from and after the date of its final passage and adoption.
