THE ANNUAL TAX LEVY ORDINANCE OF THE VILLAGE OF RINGWOOD, ILLINOIS FOR THE FISCAL YEAR BEGINNING MAY 1, 1997, AND ENDING APRIL 30, 1998

WHEREAS, the Board of Trustees of the Village of Ringwood, McHenry County, Illinois, did on the 16th day of June, 1997, pass the Annual Appropriation Ordinance for the said Village for the fiscal year beginning May 1, 1997 and ending April 30, 1997, and

WHEREAS, said Ordinance was approved by the President of the Village on the 16th day of June, 1997, the amount of which is ascertained to be the aggregate sum of Three Hundred Thousand Two Hundred Thirty Five and Zero Cents (\$320,235.00).

NOW THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD TRUSTEES OF THE VILLAGE OF RINGWOOD, ILLINOIS, as follows:

SECTION 1. That thereby and is hereby levied upon all of the taxable property within the corporate limits of the Village of Ringwood, Illinois, subject to taxation for the year 1997, the sum of Thirty-Seven Thousand Dollars and Zero Cents (\$37,000.00) for the following specific purposes designated in said Appropriation Ordinance and in the respective sums as follows:


