ORDINANCE NO. 98-11-2 AN ORDINANCE AMENDING SECTIONS 604.4 AND 604.7 OF THE SUBDIVISION ORDINANCE

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF RINGWOOD, ILLINOIS, as follows:

<u>SECTION 1.</u> Section 604.4(B) of the Subdivision Ordinance of the Village of Ringwood is hereby amended by deleting therefrom the word "metal" wherever it appears in that section.

<u>SECTION 2.</u> Section 604.4(C) of the Subdivision Ordinance of the Village of Ringwood is hereby amended to read as follows:

"C. Culverts shall meet the requirements of Section 542 of the Standard Specifications for Class A. Metal pipe culverts may be used as an alternate for installation only under drive-ways."

SECTION 3. Section 604.7B(1) is hereby amended by changing the street pavement width from 26 feet to 24 feet.

<u>SECTION 4.</u> Section 604.7.C is hereby amended by adding thereto the following sentence:

"Storm sewer shall meet the requirements of Section 550 of the Standard Specifications for Class A."
