ORDINANCE NO. 99-11-1
THE ANNUAL TAX LEVY ORDINANCE
OF THE VILLAGE OF RINGWOOD, ILLINOIS FOR THE
FISCAL YEAR BEGINNING MAY 1, 1999 AND ENDING APRIL 30, 2000

WHEREAS, the Board of Trustees of the Village of Ringwood, McHenry County, Illinois, did on the 21st day of June, 1999, pass the Annual Appropriation Ordinance for the said Village for the fiscal year beginning May 1, 1999 and ending April 30, 2000, and

WHEREAS, said Ordinance was approved by the President of the Village on the 21st day of June, 1999, the amount of which is ascertained to be the aggregate sum of five hundred thirty three thousand, seven hundred ninety nine (\$533,799).

NOW THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF RINGWOOD, ILLINOIS, as follows:

SECTION 1. That thereby and is hereby levied upon all of the taxable property within the corporate limits of the Village of Ringwood, Illinois, subject to taxation for the year 1999, the sum of thirty seven thousand dollars and zero cents (\$37,000.00) for the following specific purposes designated in said Appropriation Ordinance and in the respective sums as follows:

SECTION 4. This Ordinance shall be published in pamphlet form by and under the authority of the corporate authorities of the Village of Ringwood.

SECTION 5. This Ordinance shall take effect from and after its passage and approval and publication in pamphlet form, according to law.





WHEREAS, the Board of Trustees of the Village of Ringwood, McHenry County, Illinois,
did on the 21st day of June, 1999, pass the Annual Appropriation Ordinance for the said Village




