ORDINANCE NO. 05-3-1 AN ORDINANCE CREATING THE POSITION OF CODE ENFORCEMENT OFFICER OF THE VILLAGE OF RINGWOOD

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF RINGWOOD, ILLINOIS, as follows:

<u>SECTION 1. POSITION CREATED</u>. There is hereby created the position of Code Enforcement Officer who shall be appointed by the Village President and who shall receive such compensation as from time to time is established.

<u>SECTION 2. DUTIES</u>. The Code Enforcement Officer shall enforce the following Village Ordinances: the Zoning Ordinance, the Inoperable Vehicle Ordinance and the Nuisance Ordnances.

SECTION 3. VIOLATION OF CODE. Under the direction and supervision of the Village President, the Code Enforcement Officer shall take steps to cause the correction of any violations of any Village ordinance or code under the Code Enforcement Officer's jurisdiction. These steps include site inspection, warning, a written direction to correct the matter, filing ordinance violation charges, or filing, with the assistance of the Village Attorney, other Court actions to enforce said ordinances.

<u>SECTION 4. INSPECTIONS</u>. For purposes of making inspections the Code Enforcement Officer, Village President, members of the Village Board of Trustees and other duly authorized Village representatives shall have the right to enter upon any property at reasonable times to make inspections of such property to determine whether or not Village ordinance violations exist thereon.

<u>SECTION 5.</u> Any person, firm or corporation violating any provision of this ordinance shall be fined not less than Fifty Dollars (\$50.00) nor more than Seven Hundred Fifty Dollars (\$750.00) for each offense committed on each day during, or on which, a violation occurs or continues.

<u>SECTION 6.</u> All ordinances, or parts thereof, in conflict with the terms and provisions hereof, be and the same are hereby repealed to the extent of such conflict.

<u>SECTION 7.</u> This ordinance shall be published in pamphlet form by and under the authority of the Corporate Authorities of the Village.

<u>SECTION 8</u>. This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form, as provided by law.
