ORDINANCE 14-2-1

AN ORDINANCE PROVIDING FOR VOLUNTARY SETTLEMENT OF ORDINANCE VIOLATIONS IN LIEU OF JUDICIAL PROSECUTION THEREOF

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF RINGWOOD, MCHENRY COUNTY, ILLINOIS, as follows:

SECTION 1: Voluntary Settlement Regarding Ordinances. In fieu of judicial prosecution by the Village, any of the following described violations arising under the ordinances of the Village of Ringwood. Illinois, as amended, may be settled and compromised by the violator within the time hereinafter specified after service of the violation notice ticket by payment to the Village of Ringwood, lilinois, the sum of money herein set forth opposite such offense.
