ORDINANCE NO. 17-4- 2

An Ordinance
Amending Appropriations for Corporate Purposes for
the Fiscal Year beginning May 1, 2016
and Ending April 30, 2017
in the Village of Ringwood

Passed by the President and Board of Trustees of the Village of Ringwood this 11th day of
April, 2017

WHEREAS, The Board of Trustees of the Village of Ringwood, McHenry County, Illinois ("Trustees"), by Ordinance 16-5-1, adopted an Appropriations Ordinance for the fiscal year beginning May 1, 2016 and ending April 30, 2017; and

WHEREAS, during the course of said fiscal year the Trustees have reconsidered the amount appropriated for certain line items in said Ordinance; and

WHEREAS, the Illinois Compiled Statutes permits amendments to the Appropriation Ordinance; and

WHEREAS, the Trustees have determined that said Appropriation Ordinance should be amended in accordance with the fiscal needs of the Village.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF RINGWOOD, ILLINOIS, as follows:

SECTION 1. Ordinance #16-5-1 (the Annual Appropriation Ordinance for the fiscal year 2016-2017) be and is amended in the following respects:

- A. Line item for General Fund - Operating Supplies is increased from \$7,000 to \$9,000
- B. Line item for General Fund - Legal Services is decreased from \$100,000 to \$98,000
- C. Line Item for Motor Fuel Tax Fund - Maintenance Service Streets is increased from \$30,000 to \$74,000
- D. Line Item for Annexation Fee Fund – Capital Outlay is decreased from \$500,000 to \$456,000

SECTION 2. All portions of the Annual Appropriation Ordinance inconsistent with the foregoing are amended in the same manner and to the same extent.

SECTION 3. The foregoing adjustments to line items do not affect the total amount appropriated.

SECTION 4. This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
