ORDINANCE NO. 20-11THE ANNUAL TAX LEVY ORDINANCE OF THE VILLAGE OF RINGWOOD, ILLINOIS FOR THE FISCAL YEAR BEGINNING MAY 1, 2020 AND ENDING APRIL 30, 2021

WHEREAS, the Board of Trustees of the Village of Ringwood, McHenry County, Illinois, did on the 19th day of May, 2020 pass the Annual Appropriation Ordinance for the said Village for the fiscal year beginning May 1, 2020 and ending April 30, 2021, and

WHEREAS, said Ordinance was approved by the President of the Village on the 19th day of May, 2020, the amount of which is ascertained to be the aggregate sum of four million five hundred fifty six thousand seventy (\$4,556,070.00).

NOW THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF RINGWOOD, ILLINOIS as follows:

<u>SECTION</u> <u>1</u>. That thereby and is hereby levied upon all of the taxable property within the corporate limits of the Village of Ringwood, Illinois, subject to taxation for the year 2020, the sum of ninety four thousand (\$94,000.00) for the following specific purposes designated in said Appropriation Ordinance and in the respective sums as follows:

This Levy Ordinance is adpoted pursuant to procedures set forth in the Illinois Municipal Code, provided any limitations in the Illinois Municipal Code in conflict with this Ordinance shall not be applicable to this Ordinance, pursuat to Section 6 of Article VII of the Constitution of the State of Illinois.

<u>SECTION 4</u>. This Ordinance shall be published in pamphlet form by and under the authority of the corporate authorities of the Village of Ringwood.

 $\underline{\text{SECTION}}$ 5. This Ordinance shall take effect from and after its passage and approval and publication in pamphlet form, according to law.


