AN ORDINANCE ANNEXING PROPERTY ASSIGNED PIN 09-08-151-008 TO THE VILLAGE OF RINGWOOD

WHEREAS, the Village of Ringwood (the "Village"), McHenry County, Illinois, is a non-home rule municipality as contemplated by the Constitution of the State of Illinois, and the passage of this Ordinance constitutes an exercise of the Village's powers and functions as granted in the Constitution of the State of Illinois and applicable statutes; and

WHEREAS, a written petition has been filed with the Village Clerk of the Village of Ringwood, McHenry County, Illinois, requesting that said territory be annexed to the Village of Ringwood; and

WHEREAS, said territory is not within the corporate limits of any municipality, other than the County of McHenry, and is contiguous to the corporate boundaries of the Village of Ringwood; and

WHEREAS, the Village does not provide fire protection or library services; and

WHEREAS, all petitions, documents and other necessary legal requirements are in full compliance with the statutes of the State of Illinois, specifically 65 ILCS 5/7-1-8 et seq., of the Illinois Municipal Code; and

WHEREAS, it is in the best interests of the Village of Ringwood that said property be annexed to the Village; and

NOW, THEREFORE, be it ordained by the President and Board of Trustees of the Village of Ringwood, Illinois, as follows:

SECTION 1: That the following legally described property is hereby annexed to the Village of Ringwood:

Lot 9 in Block 33 in Indian Ridge Unit No. 2, being a subdivision of part of Sections 7 and 8, Township 45 North, Range 8, East of the Third Principal Meridian, according to the plat thereof recorded April 13, 1940 in Book 9 of plats, Pages 56 and 57 in McHenry County, Illinois (the "Property")

The Property is presently assigned PIN 09-08-151-008 located on Hiawatha Drive, Wonder Lake, Illinois.

SECTION 2: The Village Clerk of the Village of Ringwood is hereby directed to record in the Office of the Recorder and to file in the Office of the County Clerk of McHenry County, Illinois, the post office serving the territory and the Illinois Department of Transportation within 30 days of the effective date of this Ordinance, a certified copy of this Ordinance, together with the Plat of Annexation of the Property attached hereto as Exhibit A.

SECTION 3: If any section, paragraph, subdivision, clause, sentence or provision of this Ordinance shall be adjudged by any Court of competent jurisdiction to be invalid, such judgment shall not affect, impair, invalidate or nullify the remainder thereof, which remainder shall remain and continue in full force and effect.

SECTION 4: All ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of such conflict.

SECTION 5: This Ordinance shall be in full force and effect upon its passage, approval and publication in pamphlet form (which publication is hereby authorized) as provided by law.
