## VILLAGE OF RINGWOOD ORDINANCE NO. 2024 - 5 - 04

## AN ORDINANCE AMENDING THE PLAT OF SUBDIVISION FOR PIONEER OAKS OF RINGWOOD, IN THE VILLAGE OF RINGWOOD

ORDINANCE OF THE VILLAGE OF RINGWOOD ADOPTED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF RINGWOOD on this 20 day of \_\_\_\_\_\_, 2024.

WHEREAS, the Final Plat of Pioneer Oaks of Ringwood Subdivision was recorded as McHenry County Document No. 2006R0048091 and corrected by that certain Certificate of Correction recorded as McHenry County Document No. 2006R0065751; and

WHEREAS, the Final Plat of Pioneer Oaks of Ringwood Subdivision contains the properties legally described on Exhibit A, attached hereto and incorporated herein; and

WHEREAS, the Final Plat of Pioneer Oaks of Ringwood Subdivision lists Justen Lane as one of the subdivision's street names but it is more commonly known as Justen Farm Lane, both within the Village of Ringwood (*i.e.*, by the residents) and outside the Village of Ringwood (*i.e.*, by first responders); and

WHEREAS, the discrepancy in the Final Plat of Pioneer Oaks of Ringwood Subdivision's street name of Justen Lane and the commonly known street name of Justen Farm Lane has resulted in confusion in responding to emergencies; and

WHEREAS, for the health, safety and welfare of its residents, the Village of Ringwood desires to amend the Final Plat of Pioneer Oaks of Ringwood Subdivision to reflect the commonly known name of the street to Justen Farm Lane.

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF RINGWOOD, ILLINOIS as follows:

**SECTION 1:** The foregoing recitals shall be and are hereby incorporated as findings of fact as if said recitals were fully set forth herein.

**SECTION 2**: Justen Lane, on the Final Plat of the Pioneer Oaks of Ringwood Subdivision, recorded as McHenry County Document No. 2006R0048091 and corrected by that Certificate of Correction recorded as McHenry County Document No. 2006R0065751, is hereby amended to Justen Farm Lane.

**SECTION 3**: If any section, paragraph, subdivision, clause, sentence or provision of this Ordinance shall be adjudged by any Court of competent jurisdiction to be invalid, such judgment shall not affect, impair, invalidate or nullify the remainder thereof, which remainder shall remain and continue in full force and effect.

SECTION 4: All ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of such conflict.

**SECTION 5:** This Ordinance shall be in full force and effect following its passage, approval and publication in pamphlet form (which publication is hereby authorized) as provided by law.

Re: Street Name Change from "Justen Lane" to "Justen Farm Lane"

Dear Resident:

The Village of Ringwood was notified by the Fire Protection District that the name of "Justen Farm Lane" has caused periodic confusion with emergency responses to the street.

Upon review, we identified that the Final Plat of the Pioneer Oaks Subdivision lists "Justen Lane" as the actual street name for what is more commonly known by the residents as "Justen Farm Lane" and which is the postal address used by everyone in the subdivision. As a result, and after reaching it to several of the residents who hold themselves out as living on "Justen Farm Lane," the President and the Board of Trustees are considering an ordinance to amend the Final Plat of Pioneer Oaks of Ringwood Subdivision to formally change "Justen Lane" to "Justen Farm Lane."

This matter will be considered at the Village Board's regularly scheduled meeting on Monday, May 20, 2024, at 7:00 p.m., at Village Hall. You are invited to attend the Village Board meeting.
