

WHEREAS, it is the judgment and determination of the Corporate Authorities of the Village of Ringwood, Illinois that the public interest will be subserved by vacating the street, lane or alley, or part thereof, hereinafter described in Section 1 of this ordinance.




Re: Street Vacation
