## ORDINANCE NO. 98-7-4 AN ORDINANCE AMENDING SECTION 901 OF THE VILLAGE SUBDIVISION ORDINANCE

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF RINGWOOD, ILLINOIS, as follows:

SECTION 1. Section 901 of the Village Subdivision Ordinance is hereby amended by increasing the present "Fair Market Value" of improved land in and surrounding the Village from \$50,000.00 per acre to \$75,000.00 per acre and also by amending the criteria for school sites to read as follows;

400 capacity Elementary Schools (grades K-5) on 15 acres of land; 750 capacity Junior High Schools (grades 6-8) on 35 acres of land; 1,000 capacity High Schools (grades 9-12) on 60 acres of land;

and,

- SECTION 2. Any person, firm or corporation violating any provision of this ordinance shall be fined not less than Twenty Five Dollars (\$25.00) nor more than Five Hundred Dollars (\$500.00) for each offense committed on each day during, or on which, a violation occurs or continues.
- <u>SECTION 3.</u> All ordinances, or parts thereof, in conflict with the terms and provisions hereof, be and the same are hereby repealed to the extent of such conflict.
- <u>SECTION 4</u>. This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form, as provided by law.
