Dear Neighbors:

\*\* **Important change in waste and recycling service** \*\* The 5 year contract between the Village and Waste Management (WM) for residential garbage and recycling expires at the end of January 2022. As a result, your Village officials solicited proposals from WM and two other waste and recycling service providers (Flood Bros. and Lakes Disposal) for a new 5 year contract. After reviewing the proposals, the Village Board determined that Flood Bros. provided the best overall service options at the lowest cost for Ringwood residents. The Flood Bros. proposal was slightly less than Lakes Disposal and significantly less than WM.

### \*\* What you need to know and required actions \*\*

### 1. Flood Bros. - Action required - Select service option no later than January 7th.

- Review service options on page 2 of this newsletter.
- Sign up for service via one of the options below. Be prepared to provide your name, address and phone number.

  - Important issues to keep in mind -
    - Service Begins February 2, 2022.
    - Cart Deployment to homes will begin as early as January 18, 2022.
    - Collection day: Wednesday (moving from current Tuesday collection day).
    - Each residence will receive a 95 gal trash cart and 65 gal recycling cart.
    - Residents will have the option to upgrade to a 95 gal recycling
    - Additional carts for both trash and recycling available for a monthly rental cost
    - Flood Bros. offers a senior discount. To be eligible you must be age 65 or older and the owner of record for the residence. Please a submit a form to their office requesting the discount. The forms will be available on the Village website or contact Flood Bros. (see contact info above)

## 2. Waste Management - Cart Pickup -

Last pickup will be Tuesday, January 25th. Please leave your WM carts at the end of your driveway and WM will pick them up on that day. Do not use Flood Bros. carts until February 2nd. WM will not service Flood Bros. carts.

## 3. Qualifications for service -

Available to residents within the corporate limits of the Village of Ringwood only.

# New Golf Cart/UTV License Requirements and Benefits

Beginning January 1, 2022, all Golf Carts and UTV's will have license plates on their vehicles.

The choices available will be as follow:

VANITY PLATES \$75.00 Or NUMERIC PLATES \$60.00

All plates have no more than 7 characters! Annual renewals will be \$10.00, and will have re-inspection. Stickers are being eliminated as an option, because they are too hard to read. It's important to note that applicants who have already paid the \$50.00 registration fee will not pay that again. If you have already registered, vanity plates will only be \$25.00 and numeric plates will be \$10.00.

One big benefit of this new program is that Ringwood and Johnsburg will have similar licensing and registration requirements. As a result, both communities have agreed to honor each other's Golf carts and UTV's license plates. Therefore, starting in 2022, residents will have the option to trailer your golf cart/UTV to a friend's home in Johnsburg and enjoy what their community has to offer and Johnsburg residents can do the same in Ringwood. Beginning in March, please call Sue Keener, Village Clerk at 815-355-6680 to schedule an appointment to have your golf cart/UTV inspected and to purchase your new plates.

# **Administrative Adjudication**

Our Village recently partnered with the Village of Johnsburg to share services for administrative adjudication, which is the process by which citations issued under the Ringwood Municipal Code can be prosecuted outside of a formal court proceeding. The advantage of using the local adjudication process is that it does not require the Village to employ an attorney to prosecute the citations. It also allows the person receiving a citation to pay less in court costs. While the Village's goal with any code violation is to get the property owner to come into compliance, the adjudication process provides a mechanism for hopefully rare situations in which the property owner is unwilling to comply.

Another advantage of working with Johnsburg is that our Village already shares the services of Johnsburg's Code Enforcement Officer. This ensures that the same person who issues citations will already be present for any adjudication hearings.

The Village Board approved the intergovernmental agreement with Johnsburg at its November Village Board meeting. The new administrative adjudication process will go into effect on January 1, 2022.

## **Public Works Report:**

**Parking Ordinance Reminder** – At all times of the year, parking is prohibited on all Village of Ringwood roads, except Barnard Mill Road near the post office (15 minute limit). After a snowfall of two inches or more, parking is not permitted in the spaces along Barnard Mill Road near the post office until after the road has been plowed shoulder to shoulder. This parking prohibition is in effect 24 hours a day. If a 2-inch or greater snowfall occurs and your vehicle is parked along the road, you must move it or have it moved immediately so plows can get through. By doing so, you will avoid being ticketed and towed. In that scenario, an individual would not only have to pay the ticket, but the towing charge as well. Your compliance with our Parking Ordinance is appreciated.

**Mailbox Post** – With winter on its way, this would be a good time for residents to check their mailbox and post to be sure that they are sturdy and can handle the snow roll off from the plow. If repair or replacement is needed, please take the time now to do it. If your mailbox or post falls down during the winter months, the only thing that can be done at the time is a temporary fix and mail delivery may be disrupted.

Blitzed Mailboxes – If your roadside mailbox becomes a casualty during the Village's war with the wintertime elements, the Village will repair or replace it if it was damaged from direct contact with a Village contractedand-operated snow plow. However, if the damage is caused by a windrow (wall of flying snow) hurled by a passing plow, the Village will not repair or replace it. Sturdiness should be a consideration when you purchase and install your mailbox in a legal manner. It should be able withstand a force, weight, and sweep of snow flung by a passing plow. Replacement of mailboxes damaged as a result of being struck by a Village contracted snow plow will be a standard unit set on a wolmanized 4x4 wooden post. Please bear in mind, however, that sometimes downed mailboxes cannot be reinstalled immediately. In that case you will be required to pick up your mail at the post office.

**Salt Caution** – It's important to be aware that the effectiveness of road salt diminishes as the temperature drops. The lower the temperature, the less effective the salt will be. Road salt effectiveness is also reduced during freezing rain, because it's washed off the pavement by the traffic as the rain continues falling and freezing on impact. In any weather, when salt is spread, drive as if there was no salt at all. Reduce your speed and allow plenty of space between your vehicle and the one in front of you. Also, begin stopping well in advance of any stop sign or traffic signal.
