
MTFPD Preparing to Break-ground on new fire station in 2015

The McHenry Township Fire Protection District (MTFPD) hopes to break ground on station #5 in fall of 2015. As you will recall, the MTFPD purchased 10 acres on the west side of Ringwood Road to build station #5. The purpose for station #5 is to reduce response times to Ringwood and the surrounding area. In addition to the new fire station, the Village received a 3 acre land donation from the property owner for a future public works site. The Village Public Works property is located adjacent to and directly to the west of the MTFPD site (See rendering of station 5 and site plan on page 4).



Open-Burning Reminder



The McHenry County Health Department wants to remind residents of open-burning restrictions. The county public health ordinance permits residents to burn landscaping waste on weekends in April, May, October and November. The burning area must be at least 100 feet from a house, business, school or church and at least 50 feet from a barn, shed, detached garage or other accessory structures.

Only landscaping waste generated on-site - grass, leaves, limbs and shrubbery cuttings - can be burned. The McHenry County Health Department open-burning ordinance is more restrictive than the Village ordinance and therefore Ringwood residents are required to follow the McHenry County Health Departments open-burning restrictions. June 2015

Approve an ordinance addressing the payment of cable television franchise fees in the Village of Ringwood.

• Approve Prevailing Wage ordinance.

- Approve a bonus in the amount of \$2,000 for the Village Clerk and \$1,000 for the Village Treasurer.
- Approve snow plow contract between the Village of Ringwood and Upland Construction & Maintenance for the 2015/2016 winter season.

All trustees present at the June meeting voted unanimously to approve the above action, except Trustee Bushroe who was absent.

July 2015

 Approve hiring Upland Construction & Maintenance to perform additional shouldering work on Pioneer Road and landscaping work at the intersection of Barnard Mill & North Ridgeway Road.

All Trustees present at the July meeting voted unanimously to approve the above action, except Trustee Bushroe & Klimkowski who were absent.
