Your Village officials recently completed work on a second parking lot and walking path in the Village Hall park. The asphalt grindings from the recently completed road resurfacing projects were used for the parking lot and walking path sub base. This parking lot will also be used as a future construction access point for phase two construction of the Oakview Estates subdivision. As a result, for the time being the Village will not be placing the final coat of asphalt on this parking lot.

Building this parking lot and walking path would not have been possible without the generous donation from Lima Excavation and its owner Larry Lima. Lima Excavation donated all the labor to install the parking lot and walking path and donated the limestone for the walking path. Golf Carts/UTVs - Friendly Reminder



Illinois state law and Village ordinance requires the following:

- You must have a valid drivers license to operate a golf cart or UTV upon the roadways in the Village of Ringwood which are owned by and under the jurisdiction of the Village.
- Any licensed driver operating a golf cart or UTV upon the roads in Ringwood shall comply with the provisions of the Illinois Rules of the Road and the Illinois Vehicle Code.
- Golf carts and UTVs must be inspected and registered annually with the Village. Please contact Village Clerk

Sue Keener at 815-355-6680 if you have not had your golf cart or UTV registered and inspected.

- State of Illinois law prohibits the use of ATVs on public roads.

Village Roads - Friendly Reminder

If you're planning to build a new home or make improvement to an existing home, please be aware that you are prohibited from dumping construction material on the road for your project. This can create an unsafe condition for motorists and damage the road in the process.

April 2023

- Approve Professional Engineering Services Agreement between HR Green and the Village of Ringwood for FY2023/2024 for general engineering consultant services.
- Approve Professional Services agreement between HR Green and the Village of Ringwood for building plan review and inspection services.

- Approve ordinance requiring that all single family homes being constructed in the Village of Ringwood have minimum of a three-car garage.

All Trustees present at the May Village Board meeting voted unanimously to approve the above action, except Trustees Herdus and Robel who were absent.

June 2023

- There was no new or old business acted upon at the June Village Board meeting.
