Public Work Report

Resurfacing School Road - The Village Board awarded a contract in the amount of \$175,796.55 to Geske & Sons Inc to resurface School Road this summer. Geske and Sons, Inc. was the low bidder. A substantial portion of this project will be paid for with the \$100,444 that Ringwood will receive from the passage of President Biden's American Rescue Plan Act of 2021. To avoid conflicts with the school, this project is expected to be completed before the first day of school.



Crack Sealing - The Village Board hired Pavement Solutions LLC to crack seal the following Village roads in 2021: Inmans Way, Kaylins Way, Ringwood Road from Route 31 to Barnard Mill Road, Barnard Mill Road from Route 31 to Ringwood Road and all of the Roads in the Pioneer Oaks of Ringwood subdivision.

UTV/Golf Cart Registration Update

Beginning January 1, 2022, all Golf Carts and UTV's will have license plates on their vehicles. The choices available will be as follow:

Friendly Reminder About Dead, Dying and Diseased Trees



The Village of Ringwood has an ordinance requiring that all dead, dying or diseased trees be cut down. The purpose of this ordinance is to stop the spread of disease such as the Emerald Ash Bore and to keep our Village looking nice. Thank you in advance for your cooperation.

MCCD Prairie Trail

Update - The McHenry County Conservation District is in the process of repairing a drainage problem on the Prairie Trail between Ringwood and Barnard Mill Road. This project includes cutting trees down to make room for a drainage swale. During heavy rain events water ponds on Ringwood Road and the Prairie Trail, because of poor drainage along this section of the Trail. The purpose of this project is to resolve this issue and improve drainage on this section of the Prairie Trail. MCCD is expected resume work on this project in late summer or early fall. Thank you to MCCD for making this improvement.

A Friendly Reminder About Outdoor Storage

Outdoor Storage - The outdoor storage of boats, all types of watercraft, campers, recreational vehicles, motor homes, trailers of all types, all terrain vehicles, and snowmobiles, unlicensed inoperable vehicles are prohibited in the A-1 Agricultural Zoning District (10 acres or less) R-1, RR-2, R-3 and E-1 Residential Zoning Districts, B-1, B-2, B-3, O/R, I-1, and I-2 Business & Industrial Zoning Districts in the Village of Ringwood. In addition to a number of commercial properties in the Village this ordinance applies to the following residential subdivisions in the Village: Country Crossings, Glacial Trails, Oakview Estates, Pioneer Oaks, Whispering Meadows. All of downtown Ringwood and a number of individually zoned residential and commercial properties are also included under the outdoor storage requirements if your property falls under any of the the above zoning districts. Residents with RV's, campers and snowmobile trailers will be allowed to store your RV, camper or snowmobile trailer in your driveway in the 48 hours immediately prior to and returning from a trip. The purpose of this requirement is to provide an opportunity for you to prepare (load and unload) your RV, camper or snowmobile trailer for your trip. To qualify for this exception, you must contact Village Clerk Sue Keener via email at sue.keener@ringwood-il.us and provide your name and address along with the days that your RV, camper or snowmobile trailer will be parked in your driveway. Sue will the provide Randy with this information. Finally, please review your subdivision convince and restrictions. The Village doesn't enforce convince and restrictions, however most of them have the same or similar requirements regarding outdoor storage. Thank you in advance for your cooperation.

- Approve hiring Pavement Solutions LLC, to perform crack sealing on certain Village of Ringwood Roads in 2021.

All Trustees were present at the June Village Board meeting and voted unanimously to approve the above action.
